 7. The rates quoted by the bidders shall be **valid for 120 days** from the date of opening of quotations.
 8. The quotations received after due date & time shall not be accepted under any circumstances.
 9. The quotations received through e-mail or fax shall not be considered.
 10. In case the scheduled date of opening of quotations happens to be a holiday, the quotations shall be opened on next working day.
 11. HPPCL reserve its right to reject any one or all the quotations without assigning any reason thereof.
 12. The quantity can be increased or decreased at the time of issuing of supply order. **HPPCL has the discretion to award the item-wise supply order to the successful bidder quoting the lowest item rates.**
 13. Delivery of material/goods shall be **within 120 days** after the issue of supply order.
 14. All goods should be reached at Consignee Address in sealed / packed condition.
 15. If the contractor fails to deliver the material in full within the stipulated delivery period, liquidated damages shall be applicable @ 0.5 percent of the contract price per week or part thereof subject to a maximum of 5% (five percent) of the contract price.
 16. The material /goods shall be inspected by the indenting officer after receipt of consignment at store. The supplies of the material should be branded, entirely new, of the best quality to the entire satisfaction of HPPCL. In case the material is of bad / poor quality, defective, expired date and not as per specification then HPPCL reserve the right to reject the entire lot without any financial implication on the part of HPPCL.
 17. The contractor/Supplier shall furnish one set of type test parameters report , if asked for by HPPCL.
 18. The manufacture's standard warranty / guarantee shall be applicable for the supplied items. To this effect a **Guarantee Certificate** should be sent along with the dispatch documents in the event an order is placed on the firm.
 19. In case of any dispute between HPPCL & Contractor, the jurisdiction of court shall be at Kullu, (HP) only.
 20. No advance payment shall be admissible under any circumstances whatsoever to the contractor.
