Sealed item rate tenders are hereby invited by the undersigned on behalf of Himachal Pradesh Power Corporation Limited hereinafter referred to as the “Employer”/ “Owner”/ “Utility” on open tender basis for work regarding Carrying-out in-situ repair and refurbishment of Nozzle Head in respect of Integrated Kashang HEP Stage-I, HPPCL, Distt.-Kinnaur, (HP) from the experienced/reputed Bidders/ Joint Venture Firms (hereinafter referred to as the “Contractor”).

The tenders/bids complete in all respect shall be received in this office **on or before 08.04.2026** up to **11:00 AM** and shall be opened on same day at **11:30 AM** in the office of undersigned by the constituted committee in presence of bidders or their authorized representatives who may wish to be present at the time. 1. The work should be carried out to the entire satisfaction of the Engineer-in-Charge.
2. The GST shall be paid extra as per actual applicability at the time of invoicing.
3. The Contractor shall have to produce the valid Pan Card (Income Tax), GST Registration and EPFO registration along with application while purchasing the tender document.
4. All statutory provisions of various Labour Laws/Acts, PF Rules and other Statutory Provision should be duly complied with.
5. 

6. The tender must be accompanied with Bid Security / Earnest Money Deposit amounting to Rs 10,000/- only (Rupees ten thousand only).
 - The Bid Security / Earnest Money Deposit shall be forfeited, if the bidder withdraws its bid or varies any terms & conditions in regard thereto during the period of bid validity as specified in tender documents.
 - If the successful bidder fails or refuses to accept / execute the scope of work when required.
 - Bid Security/ Earnest Money Deposit of the successful bidder will be returned only after submission of Performance Bank Guarantee as per the provisions of the Contract.
7. All amounts mentioned above, except EMD, are non-refundable. EMD deposited against other procurement(s) shall not be transferable to this tender and vice versa.
8. Tenders without earnest money will not be entertained and shall be rejected out rightly.
9. Brief of eligibility criteria and qualification criteria is as under; however, the bidder shall purchase & refer the tender/bid documents for detailed eligibility and evaluation criteria which shall prevail.
 - The bidder should be a manufacturer or a reputed service provider having expertise and machinery to repair, manufacturer, rebuild or replace existing hydropower components that regularly manufactures/repairs the equipment of the type specified and has adequate technical knowledge and experience in respect of all items covered under the Scope of Work.
 - The bidder must have carried-out the similar scope of work to minimum one working site of Govt. undertaking PSUs (i.e. NHPC/NTPC/SJVNL/HPSEBL/HPPCL etc.) OR other IPPs of minimum **50 MW capacity Unit**. The Letter of Award / Contract completion certificate and Performance certificates, for certifying the same should be provided along with all other relevant documents.
 - The bidder must have experienced and qualified-in-house Mechanical Engineers having experience in manufacturing and/or repair works and certified welders for maintaining the quality welding on the hydro mechanical parts (The welder for repair and refurbishment of Nozzle Head should have performed similar nature of work at minimum one working site of Govt. undertaking PSUs (i.e. NHPC/NTPC/SJVNL/ HPSEBL/HPPCL etc.) OR other IPPs.
 - The bidder should have equipments and tools/ instruments etc. required for repair and refurbishment of Nozzle Head.
10. All the relevant documents should be sealed together in an envelope super scribed with Name of Tender "**Carrying-out in-situ repair and refurbishment of Nozzle Head in respect of Integrated Kashang HEP Stage-I, HPPCL, Distt.-Kinnaur, (HP)**" and "**The Tender Opening Date:- 08.04.2026 (11:30 AM)**" along with the name and address of the bidder clearly mentioned on the envelope.
