Tender must be accompanied by the requisite amount of earnest money indicated above and shall be deposited in the shape of bank draft/pay order/banker cheque in favour of HPPCL, Renukaji Dam Project, payable at UCO Bank, Rainka/SBI, Chuli Dadahu, Distt. Sirmaur, (H.P.), 173002. 12. The Supplier has to submit the copy of AADHAR Card, PAN, GST registration No. and latest

income tax returns at the time of application seeking the tender form.

13. The material should be in good condition and shall be inspected by the indenting officer/consignee after receiving the material at O/o GM, Renukaji Dam Project, HPPCL, Dadahu, Distt Sirmaur (HP). In case material is found of bad/poor quality or defective then HPPCL reserve the right to reject the entire material without any financial implication on part of HPPCL.

14. The rates should be FOR at O/o GM, Renukaji Dam Project, HPPCL, Dadahu, Distt Sirmaur

(HP) inclusive of all the charges whatsoever for transportation.

15. The Contractor should belong to Project Affected Families listed in Renukaji Dam Project (Documentary proof in this regard should be attached a/w application for issuance of Tender Form).

16. 100 % payment shall be made after completion of supply of material in good condition and

submission of commercial invoice.

17. GST or any other taxes/levies in respect of above work shall be payable by the supplier and HPPCL shall not entertained any claim whatsoever in this respect.

18. All statutory deductions shall be deducted as applicable under rules.

19. The supply of material shall be completed within stipulated time period specified above. In the event of failure on the part of contractor to complete the supply within the time schedule, the Engineer –in-charge may levy liquidity damage @ 1% of awarded value per week for delay in completion of supply subjected to maximum 10% of the awarded amount.
