B. Technical Specification:

1. **Application:** Spares shall be suitable for continuous use under sunlight and for direct burial.
2. **Applicable standards:** As per relevant IS/Latest edition.
3. **Voltage Grade:** 33000 Volts for HT Panel Spares and 415/600 Volts for LT Panels.
4. **Relays:** Specifications of relays to be supplied shall be the same as mentioned in the schedule and suitable to operate on DC 110 volts. Calibration and other data updating shall be done by OEM before dispatch of material or by his rep. at site. In case contractor is willing to supply relays of make other than of existing make, same shall be suitable to fix in the existing ways provided in the 33 KV HT Panel and relays setting shall be accurate to match with existing system. It is the responsibility of contractor to fix the relay in place of existing and test the same if desired by EIC of work.
5. **MCCBs :** MCCB should be confirmed to IEC 60947-2/IS/IEC 60947-2 or latest addition. MCCB shall be same in size & shape as per existing as mentioned in the schedule and shall be fixed in existing panels properly. Contractor will affix the same in existing panel if desired by EIC of work without any extra cost.
6. **33 KV HT Insulators :** 33 KV HT Insulator should be of same dimension as per existing ie. 300mm long and 100mm dia. On one side of Insulator to be provided with single bolt and other side with two bolts to affix the insulator between Panel and Bus bar. Contractor can measure dimension of insulator at site or telephonically.
7. **AC Connector :** AC shall be confirming to IS Specification and Open type Bakelite connector strip double row barrier black terminals having rating 600 Volts, 100 Amps with 05 terminals for R, Y, B, Neutral and earth complete with 10 Nos. of washers and bolts for fixing cable legs. 02 No's of holes in base plate and distance between two holes shall be same as in existing connector to affix the same in existing inverter.



8. **Test Certificate:** Two copies (one in hard and one in soft form) of manufacturers/OEM test certificates for relays, 33 KV insulators shall be supplied with the material.

2. Delivery of material/goods shall be within 30 days after the issue of supply order.
3. The evaluation of quotations shall be done without considering GST. The GST shall be paid extra as per actual applicability at the time of invoicing.
4. The quotations should be strictly as per the above specified price schedule / bill of quantity and terms & conditions of HPPCL duly signed / stamped and quotations with any deviation in the same shall be rejected.
5. The copy of GST certificate, PAN card and State/Central Govt. registration certificate/MSME certificate (if applicable)/valid certificate under Indian company act 1956 should be submitted with the offer/bid/quotation.
6. The quotation must be accompanied with earnest money in the form of a Demand Draft (DD) in favor Himachal Pradesh Power Corporation payable at Kotli/Mandi (HP) amounting to Rs. 7,000/- only (Rupees Seven Thousand only). The quotation without EMD shall not be considered for evaluation
7. The Prospective bidders are requested to submit the bid/offer in a sealed cover along with all relevant documents super scribed with notice inviting quotation (NIQ) Ref. No. and quotation opening date along with the name and address of the bidder clearly mentioned on the envelope. The envelope should be sent at the address of undersigned.
8. HPPCL shall not be responsible for delay / failure in submission of the quotations.
9. The rates quoted by the bidders shall be valid for 120 days from the date of opening of quotations.
