The cleaning activities shall be carried out in a systematic and professional manner so as to ensure restoration of thermal efficiency, reliable operation, and compliance with the operational requirements of the plant.

1. A total of twelve (12) numbers of UCB and LGB heat exchangers shall be taken up for cleaning during the execution of the work.
2. Dismantling of the respective heat exchangers required for cleaning shall be carried out by the Contractor/Vendor.
3. Thorough cleaning of all heat exchangers using suitable chemicals/cleaning agents, ensuring no damage to the equipment, tubes, or components.
4. Replacement of all oil rings, gaskets, and sealing elements installed within the heat exchangers as part of the scope of work.
5. Re-assembly of the respective heat exchangers after completion of cleaning and replacement activities, ensuring proper alignment and tightening as per standard practices.
6. Pressure testing of all heat exchangers at the specified/required test pressure to check for leakage and to ensure leak-proof performance.
7. The entire work related to cleaning, re-assembly, and testing of all heat exchangers shall be completed within a period of seven (07) days from the date of issuance of the Letter of award (LoA).

8. All tools, tackles, manpower, chemicals, consumables, safety equipment, and any other items required for successful execution of the work shall be arranged by the Contractor/Vendor and shall be deemed to be included in the quoted rates.

The 100% payment shall be released after only after successful completion of a one (01) month trial run of all the heat exchangers, during which no leakage or operational deficiency is observed. Any leakage or defect noticed during the trial run period shall be rectified by the Contractor/Vendor at no extra cost to the Employer and the contractor shall submit GSTN Invoice in original, copy of transport bility i.e. LR/GR, copy of e-way bill & other documents etc and the payment shall be released.
3. The evaluation of quotation shall be done without considering GST. The GST shall be paid extra as per actual applicability at the time of invoicing.
4. The quotation should be strictly as per the above specified price schedule / bill of quantity and terms & conditions of HPPCL duly signed / stamped and quotations with any deviation in the same shall be rejected.
5. The copy of GST certificate, PAN card and State/Central Govt. registration certificate/MSME certificate (if applicable)/valid certificate under Indian company act 1956 should be submitted with the offer/bid/quotation non submission of same the quotation shall not be considered for evaluation.

9. HPPCL shall not be responsible for delay / failure in submission of the quotation.
10. The rates quoted by the bidder shall be **valid for 120 days** from the date of opening of quotations.
11. The quotation received after due date & time shall not be accepted under any circumstances.
12. In case the scheduled date of opening of quotation happens to be a holiday, the quotation shall be opened on next working day.
13. HPPCL reserve its right to reject any one or all the quotation without assigning any reason thereof.
14. The quantity can be increased or decreased at the time of issuing of supply order.
15. The complete scope as per BOQ shall be completed **within 07 days** after the issue of job order.
16. If the contractor fails to complete the work within the stipulated completion period, liquidated damages shall be applicable @ 0.5 percent of the contract price per week or part thereof, subject to a maximum of 5% (five percent) of the contract price.
17. In case of any dispute between HPPCL & Contractor, the jurisdiction of court shall be at Distt. Shimla, (H.P.) only.
18. The standard warranty / guarantee shall be applicable for the rectification work completion for 1 year.
