**2. General**

Himachal Pradesh Power Corporation Limited (HPPCL) is a state Government Undertaking and was incorporated in December, 2006 under the Companies Act 1956, with the objective to plan, promote and organize the development of power generation on behalf of Government of Himachal Pradesh (GoHP).

The Renukaji Dam is a project of National Importance proposed on Giri River (a tributary of river Yamuna) about 1.5 km upstream of Dadahu Bridge at Dadahu in District Sirmaur (H.P.). The main objective of this project is to envisage an earth cum rock fill dam of 148 m height above the river bed with a purpose to supply drinking water to NCR Delhi @ 23 cumecs and also to generate incidental power of 40 MW capacity. This project is being funded by Govt. of India in the funding pattern of 90:10 (Centre: sharing States) for the water component.

The first stage forest clearance for the diversion of forest land involved in the Project has been accorded by the Ministry of Environment and Forest, Govt. of India on 20th Feb 2015 and all the statutory clearances & approval from CCEA has also been accorded. All the codal formalities related to Stage –II clearance has been completed and the case has been submitted to MoEF&CC to accord this approval. The foundation stone of this project has been laid by the Hon'ble Prime Minister of India on dated 27.12.2021 and the construction work of this project is likely to be started very soon.

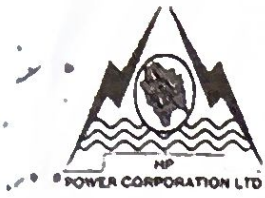
