## Scope of Work & Conditions: Comprehensive AMC Service for 10 KVA & 05 KVA online UPS (Numeric Make)

#### Terms and conditions:

#### 1) Scope of Work:-

- The service provider shall provide maintenance service to keep the UPS in good and efficient working condition covered under this contract. In addition to this, the service provider should provide preventive and corrective maintenance of UPS in presence of authorised representative of HPPCL. Service provider should carry out necessary repair and provide SUITABLE replacement (equivalent or higher configuration) of defective part(s) / equipments as required and same shall be verified by the authorised representative of HPPCL.
- 2) The AMC is comprehensive i.e. no cost of parts replaced by contractor will be borne by HPPCL except batteries.
- 3) Scope of work also includes repair of UPS along with replacement of faulty part, if any, at the expenses of service provider.
- 4) The break down calls registered by users must be attended promptly within Six (06) days else the LD charge will be levied at the rate of 0.5 % per week of the contract value upto maximum of 10% of the contract value. Thereafter, PBG will be forfeited and the contract shall be liable for termination.
- 5) HPPCL has the right to move UPS systems within the office premises with in Shimla. These equipments however will be covered under AMC at such new location also.
- The firm has to provide a new equivalent part / item with higher specifications available in the market as standby of the faulty items to HPPCL till the UPS systems are made operational in HPPCL premises.
- 7) The service provider will be responsible for any mishap or accident or untoward incidence during the maintenance of machine which may occur due to negligence of the service engineer.
- 8) The service provider shall be responsible for the discipline and good conduct of their service engineers.
- 9) Service provider should have enough spare parts of UPS at their service centre so that UPS could be repaired timely.
- 10) The preventive maintenance (PM) to be carried out once in 3 month. The preventive Maintenance includes following:
  - i. Cleaning of UPS and batteries
  - ii. Checking fitment of internal and external hardware and heating of the system

- iii. Cleaning of PCBs if any and operating power parameters.
- iv. Break up call shall be attended immediately.
- v. Checking of input /output voltage of batteries
- 11) Service engineer should submit JOB COMPLETION CERTIFICATE certified by user at each complaint. The one copy of certificate to be retained by service provider and another to be given to the HPPCL representative.
- 12) Service provider will provide its valid email-id and phone number.
- The Comprehensive AMC cost shall include, but not limited to, transportation/ administrative cost, boarding and lodging cost, etc or any other incidental cost which the contractor may incur during the execution of contract. It shall be presumed that the offer given by the vendor/ firm includes all the cost.
- 14) Engineers must be fully equipped with maintenance tool kit and accessories.
- 15) Any un-towards incidents in respect of service engineers will be the sole responsibility of the service provider. Engineers should be suitably covered for insurance.
