### OFFICE NOTE

Subject: -

Himachal Pradesh Power Sector Development program being funded by the World Bank - Activities under DLIs/Program Action Plan(PAP)/Intermediate Results Indicator by Result Areas /Key Performance Indicators (KPIs) to be carried out by HPPCL.

Year 1 of the funding in the subject cited program is nearing closure and the status was reviewed by the World Bank in its "Implementation Support Mission" held from February 12<sup>th</sup> to 16<sup>th</sup>. During the mission it was assessed that certain activities on part of HPPCL, to be completed within Year 1, are lagging behind schedule and need to be actively pursued along with the activities targeted for Year 2.

As you may kindly be aware that there are certain disbursement linked indicators (DLI) which are linked to the disbursement and the disbursements can be claimed only after achieving those indicators. Apart from the DLIs there are certain indicators grouped under the subheads like i) Project Development Objectives (PDO) ii) Program Action Plan (PAP), iii) Key Performance Indicators (KPI) and iv) Other intermediate indicator. All these indicators grouped under different subheads are not directly linked to disbursement but are otherwise legal covenants under the loan agreement and any default in achieving these targets may indirectly affect the disbursement of the loan at different stages. Achievements of indicators under all these subheads are to be reported to World Bank on quarterly basis or during the mission.

All these activities had been earlier communicated vide Director Civil Office Note dated 17.10.2022, this office email dated 19.07.2023 and office note dated 09.02.2024. Activities are again being listed out hereunder for clarity, pursuance and reporting in future on routine basis so as to enable this office to compile the achievements received from different offices and report the same to World Bank on stipulated target date.

#### 1. DLIs

DLI 1- Promotion of Integrated Resource Plan (IRP) for demand response management.

M/s Delloitte has given a draft report on IRP to be adopted by State of HP for 10 year horizon. As an immediate requirement framework of IRP is to be finalized and comments given to Chief Engineer (SO) HPSEBL/ Chief Engineer DoE on the part pertaining to HPPCL after due approval by the Management.

This is a combined task to be concluded by three wings. This unit has given the comments on generation planning aspects to your office. Your office will give the comments on automation aspects involving data transmission requirements for real time communication with SLDC and obtain comments from GM (E) on hardware part for such data transmission requirements. Your office is the HPPCL nodal officer for this DLI. It is

To conclude the process of hiring of power trader by finalizing the ToR and RFP. Draft RFP has been developed by the World Bank and they are in the process of hiring a law firm to finalize the same. HPPCL will have to work in coordination with the law firm to finalize the RFP. This office has obtained the draft RFP from the World Bank and supplied to your office. It is requested to work on the same in consultation with the O/o GM (E) as the engagement of an aggregator is second year target and huge amount of US \$ 20 m is linked to the same.

DLI:7- Strengthening Fiduciary Systems of the power sector utilities in HP.

The standard bidding documents w.r.t procurement of goods be got vetted and approved

from competent authority and submitted to this office for further submission to DoE.


