Terms and Conditions of the Contract

1. The tender should be submitted under sealed cover **super scribing the NIT number and date of opening**. Inside the sealed cover, the Tender Form and EMD should be submitted in two separate sealed covers.
2. Tender must be accompanied by the requisite amount of earnest money indicated above. Proof of deposition of EMD will be submitted by the bidder along with bid.
3. The undersigned reserve the right to reject any or all the tenders without assigning any reason thereof.
4. Tenders received without earnest money and not in prescribed manner will be rejected summarily.
5. Conditional tenders shall not be entertained
6. In case the date of receipt/ opening of tenders happen to be a holiday, same shall be received/ opened on the next working day.
7. The owners of the vehicles have to supply a copy of RC along with the fitness duly certified by the competent authority along with the copy of insurance and driving license of suitable class of vehicle & documentary proof of deposition of statutory taxes, while executing contract agreement. If the fitness/insurance/driving license/statutory taxes expire during the contractual period, the owner is bound to produce the same within a week time to the Engineer-in-charge as well as F&A Wing of this office, otherwise the agreement will stand terminated.
8. The vehicle shall be hired initially for two years. However the contract could be extended further after satisfactory performance and approval of competent authority.
9. The terms and conditions shall be modified before award as per instructions if any received from Corporate Office, Shimla.
10. All terms and conditions mentioned in the tender form will be applicable.

11. The bidder should be from a bonafide resident of Project Affected Area of Renukaji Dam (Documentary proof in this regard should be attached). First preference shall be given to project affected families and if not available from PAF's then to residents of Project Affected Zone.
12. Monthly running of the vehicle would be 3000 kms approx. This is only indicative and the vehicle would be required to run more or less than this figure as per requirement without any limit. The speedometer of the vehicle will be jointly sealed by the owner and Estate Officer. No vehicle without working speedometer shall be acceptable. In specific cases, if the speedometer breakdown, the permission for running the vehicle shall be obtained from Estate Officer.
13. In case of acceptance of rates, the owner will have to sign an agreement with HPPCL regarding terms and conditions related to hiring of vehicle /hire charges.
14. The owner shall provide driver having valid driving license and at least with five years experience of driving on all types of roads. In no case, the driver will be allowed to replace without prior approval of the Estate Officer.
15. The vehicle shall be stationed at office premises of Renukaji Dam Project at Dadahu. The vehicle should be available from 8:00 AM to 8:00-PM on all working days. It should be parked by the owner at his own risk and responsibility. In case of outstation journey, owner will make his own arrangement to park the vehicle.
16. The vehicle shall be plied on all types of Roads within and outside Dadahu including Project roads, inside the tunnels & adits and as per project requirements.
17. Normal duty hours will be 12 hours per day i.e. 8:00 AM to 8:00 PM. For additional hours in excess of 12 hours a day, the extra payment per hour shall be paid. These charges shall not be paid in case the vehicle is deputed out of headquarter/place of operation, in such case night halt charges shall be paid extra per day.
18. HPPCL shall have the right to deduct taxes /TDS/bank charges etc. at source as admissible as per rules in force from time to time. The owner has to provide the copy of PAN.
19. **The lowest if, refuse/withdraw his bid or fail to provide the vehicle then the EMD against the tender shall be forfeited absolutely.**
