## E. SUBMISSION OF BIDS:

Himachal Pradesh Power Corporation Limited (HPPCL) is to receive funds from *Agence Française de Développement* ("AFD") towards the cost of Deothal Chanju HEP (30.5 MW) located in District Chamba of Himachal Pradesh, India. It is intended that part of the proceeds of these funds will be applied to eligible payments under the contract for Civil & HM Works Package.
2. Himachal Pradesh Power Corporation Limited now invites Bids through E-Tender mode from eligible Bidders/Firms for the construction and completion of:

## Annexure-A

Brief eligible criteria is as under; however, the bidder shall download & refer the bid document for detailed eligibility/evaluation criteria:

1. All the prospective bidders shall be as per the AFD Eligible countries.
2. **Pending Litigation:** All pending litigation shall in total not represent more than one hundred percent (100%) of the Bidder's net worth and shall be treated as resolved against the Bidder.
3. **Financial Capabilities:** Minimum average annual turnover of **INR 1200 Million**, for the last **3 financial years**.
4. **Specific Construction & Contract Management Experience:**
  - i) A minimum number of similar contracts in Hydro Power Projects/ Pumped Hydro Storage Schemes as per the description below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or subcontractor between 1st January 2011 and application submission deadline:

One (1) contract having minimum value INR 2350 Million and capacity of 24 MW & above.

Or

Two (2) contracts each having minimum value INR 1500 Million and capacity of 15 MW & above.

Or

Three (3) contracts each having minimum value INR 1200 Million and capacity of 12 MW & above.
  - ii) The Bidder should have experience for Engineering, Procurement, Construction, Operation and Maintenance of at least **two (2) nos. passenger or material-cum-passenger ropeways**, each of capacity **2.5 tonne** and length **1000 meter**. (Through specialized sub contractor).
  - and
  - The Bidder should have experience for Engineering, Procurement, Construction, Operation and Maintenance of at least **two (2) nos. material ropeways** each of minimum capacity **2 tonne** and length **650 meter** (Through specialized sub contractor).
5. The bidder should have executed at least one tunnel of **minimum length of 3800 m** with **2.50 m excavated diameter** including excavation, rock supporting and lining complete.
6. The Bidder should have experience for design, manufacturing, installation and commissioning of Hydro-mechanical equipment, components and its auxiliaries etc. and should have well equipped manufacturing and testing facilities (Through specialized sub contractor).



7. The Bidder should have executed (fabrication, erection, testing and commissioning) **570 MT** or more of steel liner in an inclined or vertical pressure shaft in a single project.

8. **Specific Environmental Social and Health Safety Management (ESHS) Specifications:**

Availability of a valid ISO certification or internationally recognized equivalent (equivalency to be demonstrated by Bidder), in-house policies and procedures acceptable to the Employer for ESHS management and in-house personnel dedicated to ESHS issues.
