Registration and verification of migrant labourers.

Sir,


I am directed to say that a large number of migrant labourers including Kashmiris and Nepalis are working in Himachal Pradesh. Most of these labourers are employed in power projects, road construction works, apple orchards and in industrial areas through the contractors of concerned departments. An analysis of the crime figures shows that many Nepalis and other migrant labourers are involved in various heinous crimes such as murder, theft, burglary etc.

2. The Police is conducting special campaigns to register and verify the migrant labours. It would receive tremendous support in reducing the crime rate, if it is made mandatory for all the contractors of various departments to get their labours registered in the concerned Police Stations/Police Posts. It will help the local police authority to monitor their movements, activities and antecedents.

3. The matter has been carefully considered and it had been decided to all departments which allocate work to contractors should require the contractors to get their labourers registered with the concerned Police Stations/Police Posts. A condition to this effect may henceforth be included in the terms and conditions of contracts/work orders.

4. You are, therefore, requested to issue necessary instructions in this behalf to all concerned.
