

These orders shall come into force w.e.f. 1.4.2013.


The other terms and conditions of reimbursement etc. shall continue to be in force as per the instructions issued by the Board from time to time.

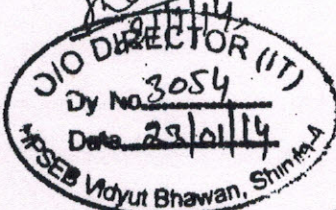


