

सन्दर्भ : नोडल अधिकारी एवं अपर प्रमुख मुख्य वन संरक्षक (एफ.सी.ए.), हिमाचल प्रदेश के पत्र संख्या एफ.टी. 48-3524/2017 (एफ.सी.ए) दिनांक 09.10.2019

महोदय,

उपरोक्त विषय पर नोडल अधिकारी एवं अपर प्रमुख मुख्य वन संरक्षक (एफ.सी.ए.), हि0प्र0 के पत्रांक दिनांक 20.03.2019 का अवलोकन करने का कष्ट करें, जिसके द्वारा विषयांकित प्रस्ताव पर केन्द्र सरकार से वन (संरक्षण) अधिनियम, 1980 की धारा-2 के तहत स्वीकृति मांगी थी।

प्रश्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक-05.08.2019 द्वारा प्रस्ताव में सैद्धान्तिक स्वीकृति प्रदान की गयी थी जिसमें उल्लिखित शर्तों की अनुपालन आख्या नोडल अधिकारी एवं अपर प्रमुख मुख्य वन संरक्षक (एफ.सी.ए.), हिमाचल प्रदेश के उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत कर दी गयी है। राज्य सरकार के प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त केन्द्र सरकार **Diversion of 25.98 ha of forest land in favour of HPPC Ltd. for the construction of Chanju-III (Hydro Electric Project -48 MW), within the jurisdiction of Chamba Forest Division, Distt. Chamba, H.P.** हेतु विधिवत् स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है:-

1. वन भूमि की विधिक परिस्थिति नहीं बदली जाएगी।
2. प्रतिपूर्ति पौधारोपण प्रस्ताव के अनुसार Kunda & Sheru waste land, Range-Tikkigarh (52-D/2) में प्रयोक्ता एजेंसी से प्राप्त राशि से कुल 52.00 हे0 वन भूमि में पौधे लगाकर किया जाएगा। प्रतिपूर्ति पौधारोपण इस पत्र के जारी होने की तिथि से एक से दो वर्षों के अन्दर पूर्ण किया जाना चाहिए।
3. राज्य सरकार धनराशि रू0 89,21,463/- हेतु संशोधित सी.ए. स्कीम इस कार्यालय में रिकार्ड हेतु प्रेषित करेगी।
4. माननीय उच्चतम न्यायालय, नई दिल्ली द्वारा I A No. 3840 in WP (c) No. 202/1995 में वर्तमान में एफ.सी.ए. के तहत भूमि के प्रत्यावर्तन पर रोक लगाई गई है। अतः राज्य सरकार मा. उच्चतम न्यायालय, नई दिल्ली द्वारा इस निर्णय लिये जाने के उपरान्त ही तदनुसार अपने स्तर पर वन भूमि के प्रत्यावर्तन हेतु जारी किए जाने वाले स्वीकृति आदेश जारी करेगी।
5. Catchment Area Treatment Plan (CATP) for the treatment of micro watersheds of Chanju-III HEP, in consonance with the comprehensive CAT Plan of Ravi Basin, Shall be prepared and implemented in consultation with the State Forest Department at the project cost.
6. एन.पी.वी. की दरों में अगर बढ़ोतरी होती है तो प्रयोक्ता अभिकरण बढ़ी दरों पर एन.पी.वी. देने के लिए बाध्य होगा।
7. प्रयोक्ता अभिकरण द्वारा प्रस्तावित वन क्षेत्र के आस-पास मजदूरों/स्टॉफ के लिये किसी भी प्रकार का लेबर कैम्प नहीं लगाया जायेगा।

8. प्रयोक्ता अभिकरण के द्वारा निर्माण कार्य के दौरान स्थल पर कार्यरत मजदूरों एवं स्टॉफ के लिये रसोई गैस/कैरोसिन तेल की आपूर्ति की जायेगी, जिससे निकटवर्ती वनों को क्षति न पहुँचे।
9. परियोजना के निर्माण व रख-रखाव के दौरान आस-पास के क्षेत्र की वनस्पतियों एवं जीव-जन्तुओं को किसी प्रकार की क्षति नहीं पहुँचायी जायेगी।
10. निर्माण कार्यों के पूर्ण होने के पश्चात् जहां-जहां संभव हो, परियोजना क्षेत्र के रिक्त स्थानों पर प्रयोक्ता अभिकरण द्वारा अपने व्यय पर वन विभाग की देख-रेख में उपयुक्त प्रजाति के पौधों का Plantation किया जायेगा।
11. वन भूमि का प्रयोग प्रस्ताव में दिये गये layout plan में दर्शाये गये उद्देश्य के अलावा अन्य किसी उद्देश्य के लिए नहीं किया जायेगा तथा किसी भी परिस्थिति में इस वन भूमि को किसी अन्य संस्था, विभाग या व्यक्ति के पक्ष में भारत सरकार की पूर्व अनुमति के बिना Transfer नहीं किया जाएगा।
12. कम से कम वृक्षों का कटान/पातन किया जाएगा, जिनकी संख्या प्रस्ताव के अनुसार 2404 trees से अधिक न हो।
13. The User Agency shall obtain the Environment Clearance as per the provisions of the Environment (Protection) act, 1986, if required, as per the provisions of the Environmental (Protection) Act, 1986.
14. The User Agency shall carry out muck disposal at pre-designated sites in such a manner so as to avoid its rolling down.
15. The dumping area for muck disposal shall be stabilized and reclaimed by planting suitable species by the user agency at the cost of project under the supervision of State Forest Department. Retaining walls and terracing shall be carried out to hold the dumping material in place. Stabilization and reclamation of such dumping sites shall be completed before handing over the same to the State Forest Department in a time bound manner as per Plan.
16. State Govt. shall ensure that the user agency shall comply the provisions of the all Rules, Regulations and Guidelines issued for laying transmission line in forest areas the time being in force, as applicable to the project.
17. The boundary of the forest land being diverted shall be demarcated on ground at the project cost, using four feet high RCC pillars, each pillar inscribed with the serial number, DGPS coordinates, forward and backward bearings and distance from pillar to pillar etc.
18. The User Agency and the State Government shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the Project.
19. The User Agency shall submit the annual self compliance report on the conditions stipulated in the approval to the State Government and the concerned Regional Office of this Ministry.
