In exercise of powers conferred by under Section 14 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and in continuation to this Department's Notification No. MPP-F(5)-03/2017 dated 22/01/2021, the Governor of Himachal Pradesh is pleased to further extend the period of issuance of notification under Section 11 of the Act ibid till 20.11.2022 in respect of land being acquired in village/mohal Maigal and Matha Niual, Tehsil Sadar Mandi, Muhal Dawahan, Kot, Koon, Jandrolla, Khad, Khalyana, Sandoh and Mahan, Tehsil Kotli, Muhal Badagaon, Wah, Bewla, Bharwari and Jhanad Tehsil Padhar, Muhal Banroo Dom, Banroo Awal, Banogi, Banwar, Charonjh, Ropru and Ball, Tehsil Joginder Nagar, District Mandi, H.P. area measuring 249-19-14 bigha for the construction of Thana Plaun Hydro Electric Project (191 MW). No further extension shall be given in any case.

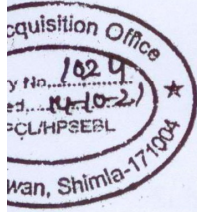




