1. The Scholarship is available for the following courses.

1.	Matriculation (from 6 th standard up to 10 th standard)	Rs. 500/-pm	One year
2.	Plus two (11 th & 12 th standard)	Rs. 700/- pm	One Year
3.	Vocational Training (ITI)	Rs. 1000/- pm	One Year
4.	Diploma in Engineering/ Pharmacy/Computer	Rs. 1500/-pm	One Year
5.	Non Professional degree (B.Sc, M.Sc, BCA)	Rs. 1600/-pm	One Year
6.	Degree in Engineering / Medicine/ Computer (or MCA).	Rs.2000/-pm	One Year
