Sanction for holding an elective office under Rule 15(1)(c) of the CCS (Conduct) Rules, 1964-regarding.

Sir/Madam,

I am directed to invite your kind attention to this Department's Office Memorandum of even number dated 3rd June, 2022, whereby the instructions issued by the Government of India vide F. No. 11013/1/2016-Estt.A-III dated 5th August, 2019 and Office Memorandum No. F. No. 11013/1/2016-Estt.A-III dated 27th February, 2020 were adopted by the State Government. As per the aforesaid instructions, no Government servant shall be permitted to hold an elective office in any body, whether incorporated or not, for more than two terms or for a period of five years, whichever is earlier. Further, prior sanction of the competent authority is mandatory in cases where a Government servant intends to contest an election in such bodies, in accordance with the existing rules.

2. It has come to the notice of the State Government that certain Government servants are not adhering to these instructions in letter and spirit and are contesting elections beyond the prescribed period without obtaining the requisite prior sanction. The matter has been viewed seriously by the Government. Accordingly, it is hereby reiterated that the instructions issued vide this Department's Office Memorandum dated 3rd June, 2022 must be complied with strictly. Any violation of these instructions shall render the concerned Government servant liable to disciplinary action under the relevant rules.


